May Kindly see the online application of Sri Manish Arora, Additional Civil Judge (Junior Division), Mathura by which he has requested for grant of permission to appear in preliminary examination of Punjab Civil Services (Judicial Branch) Examination, 2022.

In his application, Sri Manish Arora has stated that the Hon'ble High Court of Punjab and Haryana through Secretary Punjab Public Service Commission had notified 159 seats of Civil Judge (Junior Division) in Punjab Civil Services (Judicial Branch) vide Advertisement No. 2022103, Dated 06.09.2022. (Copy of the notification can be seen as attachment). He has also stated that the examination would be conducted in three stages namely; Preliminary examination, Mains/written examination and Viva-voce. He has further added that he is a native of Chandigarh (Capital of Punjab) and his family lives there, his wife is working there and his daughter is also studying there; that is why they cannot come to Uttar Pradesh to live with him, thus he wants to apply for and appear in the aforesaid examination. Thereafter, through online objection, the officer was asked to intimate the stage and date of the stated examination. In reply, the officer has stated that he wants permission for preliminary examination and date of the same is yet to be announce by the Hon'ble Punjab and Haryana High court. He has, therefore, requested to grant him permission to appear in the aforementioned examination.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 16.12.2019. It is desirable that he may be accorded permission to appear in the preliminary examination of Punjab Civil Services (Judicial Branch) Examination, 2022, at present, if the Hon'ble High Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

- 1. Government work should not suffer in any way.
- 2. No preferential treatment will be given in the matter of leave, postings and transfer.
- 3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before the Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders to the effect that permission be accorded to Sri Manish Arora, Additional Civil Judge (Junior Division), Mathura to appear in preliminary examination of Punjab Civil Services (Judicial Branch) Examination, 2022, as requested, subject to the conditions mentioned above?
