May kindly see the online application of Sushri Nancy Tiwari, Additional Civil Judge (Junior Division), Agra regarding grant of permission to accept immovable property i.e. plot having Gata no. 70 ka Minjumla situated at village Bhithauli Khurd, Pargana Lucknow, Tehsil Bakshi Ka Talaab, Distt. Lucknow measuring 153.345sq. m., as gift by her father.

In her application, Sushri Nancy Tiwari has stated that she has joined U.P. Judicial Services on 16/11/2019. Her father is willing to donate one of his immovable properties to her. For the transfer of aforesaid property in favour of her, Hon'ble Court's prior permission is necessary. (Copy of 'Gift Deed' of her father as well as 'Sale Deed' of the said plot can be seen as attachment). Therefore she has humbly prayed that Hon'ble Court may kindly be pleased to grant permission for the transfer of aforesaid property through a gift deed by her father in favour of her.

In this connection, the relevant rule relating to gift ( Rule 11 of the U.P. Government Servant's Conduct Rules, 1956) is as under :-

*11. Gifts :- A government servant shall not without previous approval of Government :-*

*(a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or*

*(b) Permit any member of his family who is dependent on him, to accept any gift, gratuity or reward from any person other than a close relation.*

It is further submitted that as the plot is going to be gifted by the father of the officer to her, out of natural love and affection, who appears to be close blood relative being father & daughter in relation. Thus, there appears to be nothing objectionable as per above mentioned rule.

May, therefore, if approved by Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra also nominated for "Disposal of the matters of Judicial Officers wherein permission/information for sale or purchase of movable/ immovable property and permission/information to accept gift under U.P. Government Servants' Conduct Rules 1956", for His Lordship's kind perusal and if His Lordship approves, Sushri Nancy Tiwari, Additional Civil Judge (Junior Division), Agra may be granted permission to accept plot having Gata no. 70 ka Minjumla situated at village Bhithauli Khurd, Pargana Lucknow, Tehsil Bakshi Ka Talaab, Distt. Lucknow measuring 153.345sq. m. as gift by her father, as requested, subject to the condition that she may furnish details of the transaction alongwith relevant papers on completion of the transaction?
