May kindly see the online application dated 06.10.2022 of Dr. Vidushi Singh, Principal Judge, Family Court, Mathura regarding grant of permission to use staff car for undertaking personal journey from Mathura to Ghaziabad on 09.10.2022 for some urgent work.

In her application, Dr. Vidushi Singh has stated that she wants to go to Ghaziabad for urgent work on 09-10-2022. The distance of Ghaziabad from Mathura is about 158 km. She wants to use official car bearing registration No. UP 70 AG 2010 for this Journey. She will pay the charges as per rules. She has, therefore, requested to place her application before the Hon'ble Court for grant of permission to use official vehicle for the aforesaid personal journey. It has been further asked from the officer that whether she has performed the journey in anticipation of permission of Hon'ble High Court and if yes, to intimate the complete details about journey i.e. total distance travelled, challan receipts and if the journey exceeds from 200 kms then to intimate about the amount paid. As intimated later by her, it is submitted that she has accomplished her journey on 09.10.2022 from Mathura to Ghaziabad in official car bearing reg. no. UP 70 AG 2010. Thus, the total distance travelled by her is 337 kms (after deducting 337-200=137 Kms.) and has paid an amount of Rs. 411/- by challan No. 0700/01/JD00016 on 13.10.2022 which has been deposited in SBI. Copy of Challan can be seen as attachment. Thus, according to G.O. no.-C.A.-1415/10-2002-Mith-2/2001 dtd. 28.09.2002, the officers are authorized to use official vehicle for 200 kms for personal use of the staff car & if it exceeds, then the concerned officer has to deposit 3 Rs. per kms. to the treasury. She has, therefore, requested that Hon'ble Court may kindly be moved to accord her permission for use of the official vehicle for the above mentioned visit.

In this connection, It is submitted that according to G.O. no.-C.A.-1415/10-2002-Mith-2/2001 dtd. 28.09.2002, the officers are permitted to use official vehicle for 200 kms for personal use of the staff car per month & if it exceeds, then the concerned officer has to deposit 3 Rs. per kms. to the treasury. She has used the official vehicle for her personal journey from Mathura to Ghaziabad and has deposited due money, the same is in accordance with the relevant G.O. As such, her request to use official vehicle appears to be considerable.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal & orders regarding grant of ex-post facto permission now to use official car bearing Registration No. UP 70 AG 2010 by Dr. Vidushi Singh, Principal Judge, Family Court, Mathura for the journey mentioned above, as per the provisions of relevant Rules and G.O.?
