In view of the above, Sri Parvinder Singh, has furnished his duly attested scanned copies of LL.M. Mark-sheets (previous & final years) and of the Degree Qualification, as supporting documents for the same.

Further, it is submitted that several objections were raised by the office asking Sri Parvinder Singh to furnish the duly attested copies of the marksheet and the Degree qualification and, in reply, the desired documents were furnished by attachment dated 05-01-2023

In connection with the above, it is submitted that Sri Parvinder Singh, joined the U.P. Judicial Service on 18.06.2018, initially as Judicial Magistrate, Muzaffarnagar. Further, it is relevant to mention here that Sri Parvinder Singh, pursued his LL.M. two-year degree course from Kurukshetra University, Kurukshetra, Haryana, in the academic year 2019-2021, after duly taking permission from this Hon'ble court after Joining the Judicial Service, copy of the permission letter so obtained has been submitted on attachment dated 05-01-2023.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (previous & final years) and copy of the Degree Qualification Sri Parvinder Singh, completed his two-year LL.M. degree course in the year 2021 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 31.08.2022, thus, the said qualification may be included in his service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Parvinder Singh, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 17.10.2022 Sri Parvinder Singh, Judicial Magistrate, Kannauj, to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (previous & final years) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Parvinder Singh, Judicial Magistrate, Kannauj, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter without entering into the fact that the Uninversity is recognised by Uninversity Grants Commission or not and without reserving any future claim of the officer regarding his qualification, if the University is not recognised for LL.M Degree Qualification.
