

## **Registrar (J)(Budget)**

May kindly see the online requisition dated 02.04.2023 of Sushri Sulochna Verma, the then Civil Judge (Junior Division), Ayodhya, Presently posted as Additional Civil Judge (Junior Division), Ayodhya, whereby she has requested for inclusion of her LL.M. qualification in her service records. In support of the same, Sushri Sulochna Verma has furnished her LL.M. credentials comprising attested copies of Marksheets of 1st year dated 02.03.2022 and 2nd year dated 26.04.2022 and Degree Qualification dated 31.08.2022 as well as copy of the online permission letter for pursuing the aforesaid course alongwith a letter dated 15.09.2023 of the Director, Directorate of Distance Education, Kurkshetra University, Kurkshetra, Haryana and letter no. F.No. 74-2/2018 (DEB-I) datd 18.10.2018, as supporting documents for inclusion of the aforesaid degree in her service records.

In this connection, it is pertinent to mention here that Sushri Sulochna Verma in her application has submitted that she pursued the aforesaid LL.M. course before joining the Judicial Services and after due permission of Hon'ble Court, she appeared in the examinations, the copy of online permission letter has been attached hereon by attachment dated 02.04.2023 under the heading 'Grant of Permission to pursue LL.M. course'.

In this regard, two objections dated 11.07.2023 & 28.11.2023 were raised by this office for clarifying the fact as to whether Kurkshetra University is recognised by Univeristy Grant Commission (UGC) and the LL.M. course purused by her through Open & Distance Learning is/was approved by UGC for the relevant years with supporting papers and also to clarify the reason as to why 1st year Marksheet was issued on 02.03.2022 for the exam month May 2020 & 2nd year Marksheet was issued on 26.04.2022 , for the exam month May 2021.

In response thereof, Sushri Sulochna Verrma, vide her submission dated 26.10.2023 has attached the required copies of relevant documents under heading of 'LL.M. Objection Document' in response of query dated 11.07.2023. She has submitted the documents relevant for the clarification about the recognition of Kurukshetra University, Kurukshetra by UGC as well as approval of her distance learning course for the respective years. Moreover, with respect to query dated 28.11.2023, the anomaly in date of result of LL.M. Part-I & II, she has submitted that she has joined the LL.M. course through Distance Learning in the year 2019 (before joining) after which she appeared for the Part-I of the said course in the year 2020 and she opted for re-evaluation in the marks of two papers i.e. L001 & L002 of Part-I and thereafter, received the re-evaluated Marksheet with updated marks on 02.03.2022, which was followed by the LL.M. 2nd year Marksheet dated 26.04.2022 and in support of this fact, she has submitted the marksheet of LL.M. (Prev.) and re-evaulated Marksheet on 28.03.2024, to this portal.

In this context, it is further submitted that Sushri Sulochna Verma, aforesaid joined the U.P. Judicial Services on 13.12.0219 as Civil Judge (Junior Division), Sitapur. Besides, as evident from submitted attested copies of Marksheets of both the years and the Degree qualification of LL.M., she has completed LL.M. course and was subsequently awarded degree from Kurukshetra Univeristy, Kurukshetra on 31.08.2022 for the examination year 2021 for LL.M., thus the said qualification may be included in his service records.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. degree may be included in the service records of Sushri Sulochna Verma, aforesaid with the formal order of Government of U.P. to be issued in this regard. Therefore, it seems appropriate that the aforesaid online requisition dated 02.04.2023 of Sushri Sulochna Verma, Additional Civil Judge (Junior Division), Ayodhya may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Ayodhya for His Lordship's kind perusal and order to the effect that a copy of online requisition dated 02.04.2023 alongwith the copy of Marksheets (both years) and Degree of LL.M., as well as attested copy of form of U.P. Nyayik Sewa of Sushri Sulochna Verma, may be sent to the Joint Secretary, Appointment Section- 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P., in the instant matter?
