May kindly see the online requisition dated 02.11.2022 of Sri Lalit Singh, posted as Registrar, Land Acquisition, Rehabilitation & Resettlement Authority, Kanpur Nagar requesting for inclusion of his LL.M. qualification in his service records vide Case Id No. 25552022. In view of the above, Sri Lalit Singh, has furnished his duly attested scanned copies of LL.M. Mark-sheets (previous & final years) and of the Degree Qualification, as supporting documents for the same.

An objection dated 05.11.2022 was raised by this office and in reply, Sri Lalit Singh, aforesaid has furnished the desired documents by attachment dated 10.11.2022.

In connection with the above, it is submitted that Sri Lalit Singh, joined the U.P. Judicial Service on 16.12.2019, initially as Additional Civil Judge(Junior Division), Kanpur Nagar. Further, it is relevant to mention here that Sri Lalit Singh pursued his LL.M. two-year degree course from Kurukshetra University, Kurukshetra, Haryana, in the academic year 2019-2021, after duly taking permission from this Hon'ble court in the middle of the course, through online portal, after Joining the Judicial Service, copy of the same is submitted on attachment dated 10-11-2022.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (previous & final years) and copy of the Degree Qualification, Sri Lalit Singh, completed his two-year LL.M. degree course in the year 2021 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 31.08.2022, thus, the said qualification may be included in his service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Lalit Singh, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 02.11.2022 Sri Lalit Singh, Registrar, Land Acquisition, Rehabilitation & Resettlement Authority, Kanpur Nagar, to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Kanpur Nagar, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (previous & final years) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Lalit Singh, posted as Registrar, Land Acquisition, Rehabilitation & Resettlement Authority, Kanpur Nagar, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter without entering into the fact that the Uninversity is recognized by Uninversity Grants Commission or not and without reserving any future claim of the officer regarding his qulaification, if the University is not recognised for LL.M Degree Qualification.
