May kindly see the application of Sri Vijay Kumar Katiyar, Deputy Director, JTRI, Lucknow regarding grant of permission for publication of a draft book titled "The Practical & Conceptual Analysis of Domestic Violence Act, 2005."

In his application, Sri Vijay Kumar Katiyar has stated that he has written a book titled "The Practical & Conceptual Analysis of Domestic Violence Act, 2005." which he wishes to get published. His draft book is strict per conditions/provisions laid down in the O.M./ G.O no. O-3143/ II-B-1968 dated 11.10.1968, Dated 11.10.1968. as per Rules 5 & 15 of UP Government Servant Conduct Rules, 1956.

He has, therefore, requested to kindly place his application before the Hon'ble Court for its kind consideration and permission to get his draft published as a book on the below conditions: -

1. The book does not bear the imprimatur of Government.
2. The author's name appears on the first page of the book without his official designation.
3. The author will give a statement under his name on the first page of the book or at any suitable place that the views and comments in the book are entirely the responsibility of the author and the Government are in no way concerned with the publication of the book.
4. The author should also ensure that the book does not contain any statement of fact or opinion which has any adverse criticism of any current or recent policy or action of the State or Central Government or Government of any other state or local authority.
5. The book is written solely with the aid of the knowledge acquired in the course of service, but it is not a mere compilation of Government rules, regulations or procedures, but reveals the author's literary work and scholarly study of the subject.
6. The work neither has nor is likely to have any connection with the author's official position; no part of the income recurring or unrecurring derived by him from the sale proceeds or royalties of the book need be credited to the general revenues

He also undertakes to abide by the instructions contained in the O.M./ G.O no. O-3143/ II-B-1968 dated 11.10.1968. He has, therefore, requested to place his request before the Hon'ble Court for kind permission for publication of the above mentioned book.

It is further submitted that as Sri Vijay Kumar Katiyar has already submitted declaration that he will abide by the conditions laid down in the O.M./ G.O no. O-3143/ II-B-1968 dated 11.10.1968, his case may be considered, but, acceptance of the request of the officer to get published the aforesaid book is on discretion of the Court.

May, therefore, if approved the instant matter may be laid before Hon'ble Mr. Justice Pritinker Diwaker, Senior Judge (J-1) for kind perusal & orders:-

1. to the effect that Sri Vijay Kumar Katiyar, Deputy Director, JTRI, Lucknow be granted permission for publication of a Book titled "The Practical & Conceptual Analysis of Domestic Violence Act, 2005.", as requested, subject to the conditions of O.M./ G.O no. O-3143/ II-B-1968 dated 11.10.1968?

Or

2. to pass any such order which His Lordship so desires.
