May kindly see the online requisition dated 05.11.2022 of Sri Shubham Verma, Presently posted as , Additional Civil Judge(Sr. Division)/ACJM, Ghaziabad requesting for inclusion of his LL.M. qualification in his service records vide Case Id No. 25632022. In view of the above, Sri Shubham Verma has furnished his duly attested scanned copies of LL.M. Mark-sheets (previous & final years) and of the Degree Qualification, as supporting documents for the same.

In the connection with the above, it is submitted that Sri Shubham Verma , joined the U.P. Judicial Service on 27.02.2015, initially as Additional Civil Judge(Junior Division), Basti. Further, it is relevant to mention here that Sri Shubham Verma pursued his LL.M. degree course from Distance Learning Education from Kurukshetra University after duly taking permission from the office of the High Court vide Court's letter no. 12133/IV-4164/Admin A-4 dated 29.08.2019 for the academic session starting 2019-2020, as per the records. In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (previous & final years) and copy of the Degree Qualification, Sri Shubham Verma , completed his two-year LL.M. degree course in the year 2021 and was subsequently awarded Degree from Kurukshetra University, Haryana on 31.08.2022, thus, the said qualification may be included in his service records as is prayed for.

Further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Shubham Verma, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid requisition dated 05.11.2022 of Sri Shubham Verma, Additional Civil Judge(Sr. Division)/ACJM, Ghaziabad to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Ghaziabad, for his Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (Two years) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Shubham Verma, Presently posted as , Additional Civil Judge(Sr. Division)/ACJM, Ghaziabad , may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
