May kindly see the online requisition dated 09.11.2022 of Smt. Priyanka Sharma, posted as, Additional Civil Judge(Junior Division), Bulandshahr, requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 25692022. In view of the above, Smt. Priyanka Sharma, has furnished her duly attested scanned copies of LL.M. Mark-sheets (previous & final years) and of the Degree Qualification, as supporting documents for the same.

Meanwhile, objections dated 15.11.2022,,12.12.2012 & 11.01.2023 were raised by the office of this court and further, in reply, Smt. Priyanka Sharma, aforesaid, has duly furnished the required documents & clarification by attachments dated 19.12.2022 & 12.01.2023 for the purpose of inclusion of the said Degree.

In the connection with the above, it is submitted that Smt. Priyanka Sharma, joined the U.P. Judicial Service on 16.12.2019, initially as Additional Civil Judge(Junior Division), Bulandshahr. Further, it is relevant to mention here that Smt. Priyanka Sharma, pursued her LL.M. course for the session 2020-2021, from Distance Learning Education from Kurukshetra University after duly taking permission from this Hon'ble court in the middle of the course, through online portal, after Joining the Judicial Service as per the records.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (previous & final years) and copy of the Degree Qualification, Smt. Priyanka Sharma, completed her two-year LL.M. degree course in the year 2021 and was subsequently awarded Degree from Kurukshetra University, Haryana on 31.08.2022, thus, the said qualification may be included in her service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Smt. Priyanka Sharma, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid requisition dated 09.11.2022 of Smt. Priyanka Sharma, Additional Civil Judge(Junior Division), Bulandshahr to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahr, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (Two years) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Smt. Priyanka Sharma, Additional Civil Judge(Junior Division), Bulandshahr, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
