May kindly see the online requisition dated 14.11.2022 of Sri Ishtiyaq Ali, Presently posted as , Judicial Member Commercial Tax, Agra requesting for inclusion of his LL.M. qualification in his service records vide Case Id No. 25842022. In view of the above, Sri Ishtiyaq Ali has furnished his duly attested scanned copies of LL.M. Mark-sheets (previous & final years) and of the Degree Qualification, as supporting documents for the same.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Agra, for his Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (Two years) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Ishtiyaq Ali, Judicial Member Commercial Tax, Agra, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
