May kindly see the online application/ request vide case id S00025892022 dated 15.11.2022 of Sri Rajesh Kumar-III, Additional District Judge, Gonda where he has requested for inclusion of his LL.M. qualification in the service records.

In support of the same, Sri Rajesh Kumar-III, aforesaid has furnished, copies of his mark-sheet of LL.M. Part-II of second year only alongwith copy of the respective degree. Therefore, vide this office objection dated 22.12.2022, he was asked to submit attested copy (not self-attested/unattested) of Mark-sheets of all the semesters/years (i.e. 1st year also) and the Degree qualification, as well as the attested(not self attested) copy of the approval letter for pursuing LL.M Degree course.

Going further, vide his response dated 17.02.2024, Sri Rajesh Kumar-III submitted the said documents with a request to take further necessary action. However, it was found that he has not attached the required copy of the approval letter for pursuing LL.M Degree course and therefore vide this office reply dated 21.03.2024 he was asked to attach the same while also clarifying the fact as to whether Kurushetra University, Haryana is recognized by University Grant Commission and the LL.M. Course pursued by him/her through Open & Distance Learning is/was approved by UGC for the relevant years with supporting papers.

In response the above objection, Sri Rajesh Kumar, vide his submission dated 27.03.2024, has attached the required copies of relevant documents under heading as 'Document for LL.M'. However, it was found that he has submitted the copy of two different marksheets of LL.M. Part II containing different date of result & date of issuance. The marksheet of LL.M. Part-II furnished by attachment dated 17.02.2024 bears the date of result 09.02.2022 & date of issuance 15.03.2022 whereas the marksheet of LL.M. Part-II furnished by attachment dated 27.03.2024 bears date of result 05.04.2022 & date of issuance 26.04.2022. Therefore, he is requested to clarify the above facts, so that the matter may be processed further.

Now, vide his reply dated 14.06.2024, Sri Rajesh Kumar-III, aforesaid has clarified the above fact by submitting that he has got low number below the standard in one subject & after the re-evaluation, he has obtained 56 number in the subject and thus has passed LLM (Prev) examination in 07.02.2022 and subsequently the provisional marksheet of LLM-II dated 09.02.2022 has been issued on 15.02.2022 in which marks of LLM- I was not included and finally marksheet of LLM-II bearing date 05.04.2022 has been issued with complete marks (including marks of LLM-I and LLM-II) on dated 26.04.2022.

In this context, it is submitted that Sri Rajesh Kumar-III, aforesaid joined the U.P. Judicial Service on 22.05.2001 as Additional Civil Judge(Junior Division), Mainpur. Besides, as evident from submitted attested copies of Mark-sheets of both the years and the Degree qualification of LL.M., he has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.08.2022 for the examination year May 2021 for LL.M. II (final year) marksheet issued on 26.04.2022 as well as for 1st year issued on 25.02.2022. He has pursued the aforesaid LL.M. Course with the prior permission of this Court and copy of the same has been furnished by attachment dated 27.03.2024 at sl. no. 5.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Rajesh Kumar-III, aforesaid with the formal order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/request dated 15.11.2022 of Sri Rajesh Kumar-III, Additional District Judge, Gonda may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Siddharth, Administrative Judge, Gonda for His Lordship's kind perusal and if His Lordship approves, a copy of online application/request dated 15.11.2022 of Sri Rajesh Kumar-III, Additional District Judge, Gonda along with copies of Degree of LL.M. and Mark-sheets of both the years of LL.M. examination, as well as attested copy of his form of U.P. Judicial Service, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of LL.M. degree in his service records?
