May kindly see the online requisition dated 22.11.2022 of Sushri Shipra, posted as, Additional Civil Judge(Junior Division), Sitapur, requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 26112022. In view of the above, Sushri Shipra, has furnished her duly attested scanned copies of LL.M. Mark-sheets (previous & final years) and of the Degree Qualification, as supporting documents for the same.

Meanwhile, An objection, dated 29.11.2022, was raised by the office of this court and further, in reply, Sushri Shipra, posted as , Additional Civil Judge(Junior Division), Sitapur, has duly furnished the required documents by attachment dated 12.12.2022 for the purpose of inclusion of the said Degree.

In the connection with the above, it is submitted that Sushri Shipra, joined the U.P. Judicial Service on 16.12.2019, initially as Additional Civil Judge(Junior Division), Sitapur. Further, it is relevant to mention here that Sushri Shipra, pursued her LL.M. course for the session starting 2019, from Distance Learning Education from Kurukshetra University, duly taking permission from this Hon'ble court through online portal, after Joining the Judicial Service, in the middle of the aforesaid course which she was already pursuing. The copy of permission so obtained, has been submitted herewith on attachment dated 22-11-2022.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (previous & final years) and copy of the Degree Qualification, Sushri Shipra, completed her two-year LL.M. degree course in the year 2021 and was subsequently awarded Degree from Kurukshetra University, Haryana on 31.08.2022, thus, the said qualification may be included in her service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sushri Shipra, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid requisition dated 22.11.2022 of Sushri Shipra, Additional Civil Judge(Junior Division), Sitapur to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Sitapur for His Lordship's kind perusal and order to the effect that a copy of her online requisition along with the copy of mark-sheets (Two years) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sushri Shipra, posted as, Additional Civil Judge (Junior Division), Sitapur, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
