May kindly see the online requisition dated 22.11.2022 of Sushri Piyushika Tiwari, the then Additional Civil Judge(Junior Division), Jaunpur & posted now as Additional Civil Judge (Junior Division), Hathras requesting for inclusion of her LL.M. qualification in her service records vide Case Id No.26192022. In view of the above, Sushri Piyushika Tiwari, has furnished her duly attested scanned copies of LL.M. Mark-sheet (Consolidated) and of the Degree Qualification, as supporting documents for the same.

In this connection with the above, it is submitted that Sushri Piyushika Tiwari, joined the U.P. Judicial Service on 16.12.2019, initially as Additional Civil Judge(Junior Division), Jaunpur. Further, it is relevant to mention here that Sushri Piyushika Tiwari, pursued her LL.M. course for the session 2018-2020, from South Asian University, New Delhi after joining the judicial service with due approval of this court, in the middle of the course, the letter of approval so obtained has been furnished by attachment dated 20.12.2022.

Several objections dated 03.12.2022, 05.04.2023 & 14.07.2023 were raised by this office and in reply, the attested copies of documents & clarification were furnished by attachment dated 21.12.2022, 18.04.2023 and 18.07.2023.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheet and copy of the Degree Qualification, Sushri Piyushika Tiwari completed her two-year LL.M. degree course in the year 2020 and was subsequently awarded Degree from South Asian University, New Delhi on 02.11.2020, thus the said qualification may be included in her service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sushri Piyushika Tiwari, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid requisition dated 22.11.2022 of Sushri Piyushika Tiwari, Additional Civil Judge (Junior Division), Hathras , to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Anish Kumar Gupta, Administrative Judge, Hathras, for His Lordship's kind perusal and order to the effect that a copy of her online requisition along with the copy of mark-sheet (consolidated) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sushri Piyushika Tiwari, Additional Civil Judge(Junior Division), Hathras may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter,
