

**Ld. Registrar (Judicial)(Budget)**

May kindly see the online requisition dated 27.11.2022 of Sri Rajeev Ranjan Mishra, the then Judicial Magistrate, Ballia & now posted as Civil Judge (Junior Division), Ghaziabad requesting for inclusion of his LL.M. qualification in his service records vide Case Id No. 26362022. In view of the above, Sri Rajeev Ranjan Mishra, has furnished his duly attested scanned copies of LL.M. Mark-sheets (previous & final years) and of the Degree Qualification, as supporting documents for the same.

In connection with the above, it is submitted that Sri Rajeev Ranjan Mishra, joined the U.P. Judicial Service on 18.11.2019, initially as Additional Civil Judge(Junior Division), Ballia. Further, it is relevant to mention here that Sri Rajeev Ranjan Mishra, pursued his LL.M. two-year degree course from Kurukshetra University, Kurukshetra, Haryana, in the academic year 2019-2021, after duly taking permission from this Hon'ble court in the middle of the course, through online portal, after Joining the Judicial Service ,copy of the same is submitted on attachment dated 27-11-2022.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (previous & final years) and copy of the Degree Qualification Sri Rajeev Ranjan Mishra, completed his two-year LL.M. degree course in the year 2021 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 31.08.2022, thus, the said qualification may be included in his service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Rajeev Ranjan Mishra, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 27.11.2022 of Sri Rajeev Ranjan Mishra, Judicial Magistrate, Ballia, to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (previous & final years) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Rajeev Ranjan Mishra, the then Judicial Magistrate, Ballia & now posted as Civil Judge (Junior Division), Ghaziabad may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter?
