P. Nyayik Sewa of Sri Rajeev Ranjan Mishra, the then Judicial Magistrate, Ballia & now posted as Civil Judge (Junior Division), Ghaziabad may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter?
