May kindly see the online requisition dated 13.12.2022 of Sri Sumit Gutpa-I, posted as Additional Civil Judge (Junior Division), Lucknow, requesting for inclusion of his LL.M. qualification in his service records vide Case Id No. 26592022. In view of the above, Sri Sumit Gutpa-I, has furnished his duly attested scanned copies of LL.M. Mark-sheets of all semesters and of the Degree Qualification, as supporting documents for the same.

In connection with the above, it is submitted that Sri Sumit Gutpa-I, joined the U.P. Judicial Service on 16.12.2019, initially as Additional Civil Judge(Junior Division), Ballia. Further, it is relevant to mention here that Sri Sumit Gutpa-I pursued his LL.M. two-year degree course from Banaras Hindu University, Varanasi, in the academic year 2018-2020, after duly taking permission from this Hon'ble court, vide Court's letter no. 6288/IV-5108/Admin A-4 dated 06.07.2021 in the middle of the course, after joining the Judicial Service and copy the permission letter is submitted on attachment dated 13-12-2022.

In addition to the above, as evident from submitted attested copy of LL.M mark-sheets (all four semesters) and the copy of Degree Qualification, Sri Sumit Gutpa-I, completed his two-year LL.M. degree course in the year 2021 and was subsequently awarded the LL.M. Degree from Banaras Hindu University, Varanasi, on 13.01.2022, thus, the said qualification may be included in his service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Sumit Gupta-I, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 13.12.2022 Sri Sumit Gutpa-I, Additional Civil Judge (Junior Division), Lucknow, to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (all four semesters) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Sumit Gutpa-I, Additional Civil Judge (Junior Division), Lucknow,, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
