May kindly see the online requisition dated 22.12.2022 of Smt. Anchal Chandel, the then Additional Civil Judge(Junior Division), Gonda & now posted as Additional Civil Judge(Junior Division), Hathras requesting for inclusion of LL.M. qualification in her service records vide Case Id No. 26712022. In view of the above, Smt. Anchal Chandel, has furnished her duly attested scanned copies of LL.M. Mark-sheets of two years and of the Degree Qualification as well as documents related to the University, as supporting documents for the same.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets and of the Degree Qualification, Smt. Anchal Chandel, aforesaid has completed her two-year LL.M. degree course in the year 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 31.08.2022, thus the said qualification may be included in her service records, as prayed for.

Several objections dated 11.01.2023, 05.04.2023 & 11.07.2023 were raised by this office and in reply, desired documents & clarification/supporting documents have been provided by attachment dated 07.02.2023, 20.04.2023 & 15.07.2023.

In connection with the above, it is submitted that Smt. Anchal Chandel, joined the U.P. Judicial Service on 16.11.2019, initially as Additional Civil Judge(Junior Division), Gonda. Further, it is relevant to mention here that Smt. Anchal Chandel, pursued her two-year LL.M. degree course from Kurukshetra University, Kurukshetra, Haryana in the year 2019-2021, after joining the judicial service in the middle of the course, with due approval of this court, the letter of permission so obtained has been furnished by attachment dated 06.02.2023.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Smt. Anchal Chandel, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 22.12.2022 of Smt. Anchal Chandel, Additional Civil Judge(Junior Division), Hathras to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Anish Kumar Gupta, Administrative Judge, Hathras for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Smt. Anchal Chandel, Additional Civil Judge(Junior Division), Hathras may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
