

## **Ld. Registrar (J)(Budget)**

May kindly see the online requisition dated 21.12.2022 of Sri Gandhrv Patel, the then Additional Civil Judge (Junior Division), Bahraich, presently posted as Civil Judge(Junior Division), Iglas-Aligarh requesting for inclusion of his LL.M. qualification in his service records vide Case Id No.S00026862022. In view of the above, Sri Gandhrv Patel, has furnished his duly attested scanned copies of LL.M. Mark-sheets (previous & final years) and of the Degree Qualification, as supporting documents for the same.

In connection with the above, it is submitted that Sri Gandhrv Patel joined the U.P. Judicial Service on 15.11.2019, initially as Additional Civil Judge(Junior Division), Bahraich. Further, it is relevant to mention here that Sri Gandhrv Patel, pursued his LL.M. two-year degree course from Kurukshetra University, Kurukshetra, Haryana, in the academic year 2019-2021, after duly taking permission from this Hon'ble court in the middle of the course, through online portal, after Joining the Judicial Service, and the copy of the same has been furnished by attachment 21.12.2022.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (previous & final years) and copy of the Degree Qualification Sri Gandhrv Patel, completed his two-year LL.M. degree course in the year 2021 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 31.08.2022, thus, the said qualification may be included in his service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Gandhrv Patel, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 21.12.2022 of Sri Gandhrv Patel, the then Additional Civil Judge (Junior Division), Bahraich, presently posted as Civil Judge(Junior Division), Iglas-Aligarh, to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Aligarh, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (previous & final years) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Gandhrv Patel, the then Additional Civil Judge (Junior Division), Bahraich, presently posted as Civil Judge(Junior Division), Iglas-Aligarh may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter relating to inclusion of LL.M. Degree Qualification in his service records?
