

## **Ld. Registrar (Judicial)(Budget)**

May kindly see the online requisition dated 09.10.2023 of Sri Chandan Singh, the then Nyayadhikari Gram Nyayalaya, Sikendepur Ballia, presently posted as Judicial Magistrate, Ballia, requesting for inclusion of his LL.M. qualification in his service records vide Case Id No. 27022022. In view of the above, Sri Chandan Singh, has furnished his duly attested scanned copies of LL.M. Mark-sheets (all semesters as well as Consolidated) and of the Degree Qualification, as supporting documents for the same.

In the context, it is submitted that Sri Chandan Singh joined the U.P. Judicial Service on 19.04.2022, initially as Additional Civil Judge(Junior Division), Ballia. Further, it is relevant to mention here that Sri Chandan Singh, pursued his LL.M. course for the session completed in 2020, from University of Allahabad, Allahabad prior to Joining the Judicial Service, as per records.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (all semesters) and copy of the Degree Qualification, Sri Chandan Singh, completed her two-year LL.M. degree course before joining the Judicial Service on 06.01.2021 and was subsequently awarded Degree from University of Allahabad, Allahabad on 08.11.2021 for the year 2020, thus the said qualification may be included in his service records, as is prayed for.

Further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Chandan Singh, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid requisition dated 09.10.2023 of Sri Chandan Singh, the then Nyayadhikari Gram Nyayalaya, Sikendepur Ballia, presently posted as Judicial Magistrate, Ballia to the Government of U.P. in order to obtain necessary orders of the government.

Therefore, If approved, the matter may kindly be placed before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Ballia, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (four semesters as well as consolidated) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Chandan Singh, the then Nyayadhikari Gram Nyayalaya, Sikendepur Ballia, presently posted as Judicial Magistrate, Ballia may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter,
