May kindly see the online application dated 04.01.2023 of Sri Pankaj Kumar Singh, District & Sessions Judge, Bulandshahar regarding grant of permission to use staff car for undertaking personal journey from Bulandshahar to Lucknow on 24.12.2022 in the morning & will return Bulandshahar on 01.01.2023 in the evening.

In his application, Sri Pankaj Kumar Singh has stated that may be permitted to go to Lucknow on 24.12.2022 at 08.00am in the morning and he will return Bulandshahar on 01.01.2023 at 08.00pm in the evening by the official vehicle no. UP 13 AG 0496 and will pay the charges as applicable rules. He has, therefore, requested to place his application before the Hon'ble Court for grant of permission to use official vehicle for the aforesaid personal journey. It has been further asked from the officer that whether he has performed the journey in anticipation of permission of Hon'ble High Court and if yes, to intimate the complete details about journey i.e. total distance travelled, challan receipts and if the journey exceeds from 200 kms then to intimate about the amount paid. As intimated later by him, it is submitted that he has accomplished his journey from Bulandshahar to Lucknow in official car bearing reg. no. UP 13 AG 0496. Thus, the total distance travelled by him is 1055 km. and has paid an amount of Rs. 3,165/- by challan No. A200012 on 02.01.2023 which has been deposited in SBI, Bulandshahar. Copy of Challan can be seen as attachment. Thus, according to G.O. no.-C.A.-1415/10-2002-Mith-2/2001 dtd. 28.09.2002, the officers are authorized to use official vehicle for 200 kms for personal use of the staff car & if it exceeds, then the concerned officer has to deposit 3 Rs. per kms. to the treasury. He has, therefore, requested that Hon'ble Court may kindly be moved to accord him permission for use of the official vehicle for the above mentioned visit.

In this connection, It is submitted that according to G.O. no.-C.A.-1415/10-2002-Mith-2/2001 dtd. 28.09.2002, the officers are permitted to use official vehicle for 200 kms for personal use of the staff car per month & if it exceeds, then the concerned officer has to deposit 3 Rs. per kms. to the treasury. He has used the official vehicle for his personal journey from Bulandshahar to Lucknow and has deposited due money, the same is in accordance with the relevant G.O. As such, his request to use official vehicle appears to be considerable.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Bulandshahar Judgeship for His Lordship's kind perusal & orders regarding grant of ex-post facto permission now to use official car by Sri Pankaj Kumar Singh, District & Sessions Judge, Bulandshahar for the journey mentioned above, as per the provisions of relevant Rules and G.O.?
