May kindly see online application dated 11.01.2023 of Sushri Shilpi Chauhan, Additional Chief Judicial Magistrate, Shahjahanpur, regarding adopting the surname of her husband, Mr. Rishabh Chaturvedi, in place of the existing one, i.e. 'Chauhan' in her service records, thereby changing her name from 'Shilpi Chauhan' to 'Shilpi Chaturvedi' after her marriage alongwith marriage certificate & affidavit for change of name submitted hereon this portal under the respective headings, i.e. 'Marriage Certificate' & 'Affidavit for Change of Name'. Further, she has also requested to add name of her husband in place of her father's name in her service records.

In this matter, it is pertinent to mention here that an objection was raised against the said application on 17.01.2023, vide which, Sushri Shilpi Chauhan, aforesaid was requested to publish the information in regard to her change of surname, in one National and Local Newspaper, stating therein the relevant prayer as required in terms of provisions contained in G.O. No. 3497/III-500(5)-46 dated 06-11-1946 and send the said notices alongwith the original affidavit in this regard, preferably by registered post.

Going further, now on 10.02.2023, Sushri Shilpi Chauhan, aforesaid has submitted the required Newspapers cuttings after publishing notices regarding change of her surname in newspapers, i.e. The Time of India of 19.01.2023 & Amar Ujala of 23.01.2023, submitted hereon this portal under the heading 'Published Notices along-with her letter dated 07.02.2023 under heading 'Covering Letter' as well as by registered post bearing endorsement no.313/I dated 07.02.2023 of the District Judge, Shahjahanpur, which have been forwarded on this portal on 11.02.2023.

It is further submitted that appointing authority of Judicial Officers of U.P. Nyayik Sewa is Government of U.P., therefore it seems proper that aforesaid application of Sushri Shilpi Chauhan, Additional Chief Judicial Magistrate, Shahjahanpur, regarding change of her surname, may be sent to the Government of U.P. for obtaining orders in this matter.

In the facts and circumstances as mentioned above, if approved by Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Shahjahanpur, letter dated 07.02.2023 of Sushri Shilpi Chauhan, Additional Chief Judicial Magistrate, Shahjahanpur, regarding change of her surname from 'Chauhan' to 'Chaturvedi', thereby changing her name from 'Shilpi Chauhan' to 'Shilpi Chaturvedi, on account of her marriage, may be sent along-with original Newspapers cutting (two), original affidavit in this regard and photocopy of her application form of U.P. Nyayik Sewa, to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining orders of the Government in this matter ?
