May kindly see the online requisition dated 09.01.2023 of Sushri Manjula Mishra, posted as Judicial Magistrate, Balrampur requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 27102023. In view of the above, Sushri Manjula Mishra, has furnished her duly attested scanned copies of LL.M. Mark-sheets (all semesters) and of the Degree Qualification, as supporting documents for the same.

In the connection with the above, it is submitted that Sushri Manjula Mishra, joined the U.P. Judicial Service on 16.12.2019, initially as Additional Civil Judge(Junior Division), Balrampur. Further, it is relevant to mention here that Sushri Manjula Mishra, pursued her LL.M. course for the session 2014-2016, from University of Lucknow, Lucknow, before Joining the Judicial Service, as per the records submitted in support of her LL.M. Qualification.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (all semesters) and copy of the Degree Qualification, Sushri Manjula Mishra completed her two-year LL.M. degree course in the year 2016 and was subsequently awarded Degree from University of Lucknow, Lucknow on 12.01.2017, thus the said qualification may be included in her service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sushri Manjula Mishra aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid requisition dated 09.01.2023 of Sushri Manjula Mishra, Judicial Magistrate, Balrampur, to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Balrampur, for his Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (four semesters) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sushri Manjula Mishra, posted as Judicial Magistrate, Balrampur, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter, without entering into the fact that the University is recognised by University Grants Commission or not and without reserving any future claim of the officer regarding his qualification, if the University is not recognised for LL.M Degree Qualification.
