May kindly see the online application of Sri Mayuresh Srivastav, Judicial Magistrate, Agra regarding information about sale of his old Maruti Suzuki Wagon R Lxi Duo car bearing reg. no. UP50 Y 9860, intimated through his application dated 10.01.2023.

Through his application, Sri Mayuresh Srivastav has stated that he had a Maruti Suzuki, Wagon R LXI Duo Car bearing registration no. UP50-Y-9860. The said car was 2011 made and several technical and mechanical faults had crept into the car. It was due to that reason that he had sold that car to Mr. Ramagya Yadav S/o Late Chauthi Yadav R/o Khanpur Bujurg, Post Ghosi, P.S. and Tehsil Ghosi, District Mau, U.P. on 12-12-2022 for Rs. 1,30,000/-. He has also stated that the buyer is not related to him. Neither any case of the buyer is pending in his Court nor he has decided any case of the buyer before. Moreover, the officer has prayed for unconditional apology that he didn't seek the prior permission of the Hon'ble Court for selling the car. & has assured that he will remain vigilant in the future. The officer has therefore, intimated about the sale of his old car for kind perusal of this Hon'ble Court.

In this connection, it is submitted that the officer was the owner of the said car since his joining of judicial service. In this connection, it is submitted that the relevant rule relating to transfer of movable property [Rule-24 (2) of U.P. Government Servant's conduct Rule-1956] runs as under:

24 (2) "A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority.

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

As such, the matter is now upto the discretion of Hon'ble Court either to accept the information submitted by the officer, as requested by the officer to regularize the matter or to pass any other order, which deem fit and proper.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956" for the District Agra, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
