May kindly see the online requisition dated 05.06.2023 of Sri Gaurav Dwivedi, Civil Judge (Junior Division), Shrawasti at Bhinga whereby he has requested for inclusion of his LL.M. qualification in his service records. In support of the same, Sri Gaurav Dwivedi has furnished his LL.M. credentials comprising attested copies of Mark-sheets of 1st Year dated 27.02.2021 and 2nd year dated 09.02.2022 & Degree Qualification dated 31.08.2022 as well as copy of the online permission letter for pursuing the aforesaid course along-with a letter dated 13.08.2018 of the Director, Directorate of Distance Education, Kurukshetra University, Kurukshetra and letter no. F.No.122-1/2017(DEB-IV) Dated: 25.06.2018, as supporting documents for inclusion of the aforesaid degree in his service record.

In this connection, it is pertinent to mention here that Sri Gaurav Dwivedi in his application has submitted that he pursued the above-mentioned LL.M. course after joining the judicial service on being granted the permission of this Hon'ble Court in the middle of the said course, the copy of online permission letter has been attached hereon by attachment dated 14.01.2023 under the heading "Permission of Hon'ble Court".

In this regard, several objections dated 17.06.2023 & 17.08.2023 were raised by this office for furnishing the attested copies of LL.M. credentials as well as copy of documents related to recognition Kurukshetra University, Kurukshetra, Haryana and approval of the aforesaid course. In reply, thereto, he has furnished desired documents by attachment dated 12.08.2023 & 04.12.2023.

In this context, it is submitted that Sri Gaurav Dwivedi, aforesaid joined the U.P. Judicial Service on 16.11.2019 as Metropolitan Magistrate, Kanpur Nagar. Besides, as evident from submitted attested copies of Mark-sheets of both years and the Degree qualification of LL.M., he has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra for the examination year 2021, and was subsequently awarded the degree on 31.08.2022, thus the said qualification may be included in his service-records.

It is further submitted that appointing authority of Judicial Officers, is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Gaurav Dwivedi, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 05.06.2023 of Sri Gaurav Dwivedi, Civil Judge (Junior Division), Shrawasti at Bhinga may be sent to the Government of U.P. for obtaining necessary orders.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Manjive Shukla, Administrative Judge, Shrawasti at Bhinga for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with copy of Mark-sheets (both years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Gaurav Dwivedi, Civil Judge (Junior Division), Shrawasti at Bhinga, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
