

**Registrar (Judicial)(Budget)**

May kindly see the online requisition dated 27.01.2023 of Smt Ayushi Chaturvedi, the then Additional Civil Judge (Junior Division), Rae Bareli, presently posted as Civil Judge (Junior Division), Hamirpur, requesting for inclusion of LL.M. qualification in her service records vide Case Id No. 27312023. In support of her application, Smt Ayushi Chaturvedi furnished attested copies of LL.M. credentials comprising of LL.M. Mark-sheets of both the years and copy of Degree for inclusion of her qualification in the service records. Along with her LL.M. credentials, she has also furnished online permission (kindly see attachment dated 21.01.2023), approved by Hon'ble the Chief Justice, the then Administrative Judge, Rae Bareli, dated 12.04.2021, to pursue LL.M. through distance learning mode from Kurukshetra University, Kurukshetra.

In this connection, it is submitted that Smt Ayushi Chaturvedi, joined the U.P. Judicial Service on 15.11.2019 as Additional Civil Judge (Junior Division), Rae Bareli. Besides, as evident from submitted attested copies of Mark-sheets (Two- years) and Degree of LL.M., Smt Ayushi Chaturvedi completed two years LL.M. course (from distance learning mode) in the year May 2021 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 15.12.2022 for the session May 2021, thus said qualification may be included in her service-records.

In this context, it is submitted that an online query, dated 11.07.2023, was made by the office of Admin A-1 section asking Smt Ayushi Chaturvedi to furnish documents related to recognition of Kurukshetra University and approval of LL.M. course by University Grants Commission. In compliance of which, Smt Ayushi Chaturvedi furnished the documents relevant to recognition of Kurukshetra University and approval of LL.M. course by UGC (kindly see attachment dated 12.07.2023 under heading 'Declaration and UGC recognition letter).

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Smt Ayushi Chaturvedi, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 27.01.2023 of Smt Ayushi Chaturvedi, Civil Judge (Junior Division), Hamirpur, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Syed Aftab Husain Rizvi, Administrative Judge, Hamirpur, for His Lordship's kind perusal and order to the effect that a copy of her application along with copy of Mark-sheets (two years) and Degree of LL.M. (uploaded online on 27.01.2023) as well as attested copy of form of U.P. Nyayik Sewa of Smt Ayushi Chaturvedi, Civil Judge (Junior Division), Hamirpur, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
