May Kindly see the online application of Sushri Radha Kulshreshtha, Civil Judge (Junior Div.), Saharanpur by which she has requested for grant of permission for her appearance in the Interview of Delhi Judicial Services Examination 2022 and grant of 'No Objection Certificate' for the same.

In her aforesaid online application, Sushri Radha Kulshreshtha has stated that She has cleared the mains examination of Delhi Judicial Services Examination prior to her appointment as Civil Judge (J.D.) FTC, Saharanpur and she had been shortlisted for the interview in the above mentioned examination. She has also stated that she applied to the Hon'ble Court for the grant of NOC through letter dated 07.12.2022 and have appeared in interview in the anticipation of grant of NOC from the Hon'ble Court and submitted that she had to give an undertaking to the respected Registrar of Hon'ble High Court of Delhi to produce the NOC within 15 days of the interview. She therefore requested to kindly grant her the NOC so that She can provide the same to the respected Registrar of Hon'ble High Court of Delhi within stipulated time.

Then, the online Court's objection has been sent to the officer with the request to clarify as to why she has not earlier requested for issuance of 'No Objection Certificate' for appearing in the interview of Delhi Judicial Services examination 2022 and also be asked to upload the mains result by highlighting her name, for taking further necessary action in the matter

In reply of the aforesaid objection, the officer has stated in her online application dated 22.02.2023 that She sought permission to get the NOC from the Hon'ble High Court through letter no. 1921/XV/22 dated 07.12.2022 and also attached copy of offline letter dated 07.12.2022 and shortlisted list of candidate for Viva-voce in the attachment.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 01.12.2022 and had submitted offline application dated 07.12.2022 for grant of permission to appear in interview of Delhi Judicial Services Examination,2022 which has been marked to the dealing assistant on February, 2023. And this application has clearly mentioned the permission of appearance in interview instead of issuing 'No-objection-Certificate' for her appearance in the Interview of Delhi Judicial Services Examination 2022.

It is pertinent to mention here that as the officer has already appeared in the interview of Delhi Judicial Services examination, 2022 of the same; now it is on the discretion of Hon'ble High Court either to grant her ex-post facto permission for her appearance in the interview of Delhi Judicial Services examination, 2022 and issuance of 'No Objection Certificate' for the same, as the officer had to give an undertaking to the respected Registrar of Hon'ble High Court of Delhi to produce the NOC within 15 days of the interview or to pass any other order which His Lordship deems fit and proper.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Saharanpur for His Lordship's kind perusal and orders to the effect that ex-post facto permission be granted to Sushri Radha Kulshreshtha, Civil Judge (Junior Div.), Saharanpur for her appearance in the Interview of Delhi Judicial Services Examination 2022 as well as to issue offline 'No Objection Certificate', under the signature of I/c Joint Registrar (Judicial) (Budget) in favour of the officer as she has already appeared in the interview of Delhi Judicial Services Examination 2022, as requested?

To pass any other order which His Lordship deems fit and proper.
