Ltd. The coloniser promised him the execution of sale deed by his company. But later on it came to his knowledge that the property is stil not in the name of said Coloniser. So the company has now promised him to return that amount of 12 Lacs, which will be paid to the transferes through cheques. May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Lakhimpur Kheri, also nominated for "Disposal of the matters of the Judicial Officers, wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servants' Conduct

Rules 1956" for the district Lakhimpur Kheri, for His Lordship's kind perusal and if His Lordship approves, Sri Lakshmi Kant Shukla, District & Sessions Judge, Lakhimpur Kheri may be granted permission to purchase plot measuring 500 sq. m. from Gata No.-217 ta, area 0.1250 hectare, situated at village Taal Kandla, Pargana-Haweli, Tehsil Sadar, Gorakhpur from Sri Rattan S/o Ram Adhar, Sri Vishun S/o Gama & Smt. Tara W/o Gama, all R/os Village Jungal Sikari @Khorabad, Teh-Sadar, District Gorakhpur for Rs. 20,00,000/- as requested, subject to the condition that the relevant papers of the transaction alongwith copy of the sale deed be furnished by him immediately on completion of the transaction?
