May kindly see the online requisition dated 30.01.2023 of Sushri Meher Jahan, posted as Judicial Magistrate, Auraiya, requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 27452023. In view of the above, Sushri Meher Jahan, has furnished her duly attested scanned copies of LL.M. Mark-sheets of all four semesters (consolidated as well as separately) and of the Degree Qualification, as supporting documents for the same.

In connection with the above, it is submitted that Sushri Meher Jahan, joined the U.P. Judicial Service on 18.11.2019, initially Judicial Magistrate, Auraiya. Further, it is relevant to mention here that Sushri Meher Jahan pursued her LL.M. two year degree course from Aligarh Muslim University, Aligarh, in the year 2017-2019, before joining the Judicial Service.

In addition to the above, as evident from submitted attested copy of LL.M mark-sheets (all four semesters) and the copy of Degree Qualification, Sushri Meher Jahan, completed her two-year LL.M. degree course in the year 2019 and was subsequently awarded the LL.M. Degree from Aligarh Muslim University, Aligarh, on 20.01.2020, thus, the said qualification may be included in her service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sushri Meher Jahan, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 30.01.2023 of Sushri Meher Jahan, Judicial Magistrate, Auraiya, to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mrs. Justice Sadhna Rani (Thakur), Administrative Judge, Auraiya, for Her Lordship's kind perusal and order to the effect that a copy of her online requisition along with the copy of mark-sheets (all four semesters) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sushri Meher Jahan, Judicial Magistrate, Auraiya, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
