Hence, it seems proper to send the aforesaid online requisition dated 30.01.2023 of Sushri Meher Jahan, Judicial Magistrate, Auraiya, to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mrs. Justice Sadhna Rani (Thakur), Administrative Judge, Auraiya, for Her Lordship's kind perusal and order to the effect that a copy of her online requisition along with the copy of mark-sheets (all four semesters) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sushri Meher Jahan, Judicial Magistrate, Auraiya, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
