May kindly see the online application of Sri Utkarsh Chaturvedi, District & Sessions Judge, Bahraich regarding information to sell his Mahindra car, intimated through his application dated 04.02.2023.

Through his application, Sri Utkarsh Chaturvedi has stated that he was the owner of one Mahindra Car bearing registration no. UP 43 S 7500 which was originally purchased by his father late Sri Bihari Lal Chaube. After his death, the said vehicle was mutated in the officer's name. Information in regard to the said vehicle has already been submitted by the officer through the property statement. The said vehicle was manufactured in the year February 2013. The vehicle was old, therefore, the said vehicle was sold out on 09.11.2022 to Sri Dharmendra Kumar Patel S/o Sri Ram Nihor Patel, R/o Chhitauni Kotwa Lohwa Varanasi, U.P. for Rs. 4,50,000/- through the registered garage AMIT MOTORS PRIVATE LTD., GONDA and commission Rs. 1,500/- was paid through cheque no. 158347 to the company. The amount of consideration has credited the account no. 31599822199 of the officer through RTGS/NEFT (copy of sale certificate, RC & statement of A/c can be seen as attachment). The officer has therefore, intimated about the sale of his old car for kind perusal of this Hon'ble Court.

In this connection, it is submitted that the aforementioned car has been purchased by the father of the officer & later after his death was mutated in the officer's name. Thus, he has sold the car through a regular and reputed dealer. There seems to be nothing objectionable as per the Rule-24 (2) of U.P. Government Servant's conduct Rules, 1956, which is as follows:-

*24 (2):- "A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;*

*Provided that no Government servant shall enter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."*

May, therefore, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Bahraich, also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956" for the District Bahraich, for His Lordship's kind perusal and information under Rule 24 (2) of U.P. Government Servant's Conduct Rules, 1956?
