

## **Ld.Registrar (Judicial)(Budget)**

May kindly see the online requisition dated 05.02.2023 of Sri Bhupendra Pratap, the then Additional District Judge (FTC), Saharanpur & presently posted as Additional District & Sessions Judge, Saharanpur requesting for inclusion of LL.M. qualification in his service records vide Case Id No. 27842023. In support of his application, Sri Bhupendra Pratap has furnished attested copies of LL.M. credentials comprising of LL.M. Mark-sheets of both the years and copy of Degree for inclusion of his qualification in the service records. Along with his LL.M. credentials, he has also furnished the copy of online permission letter obtained from this Court to pursue LL.M. Course through distance learning mode from Kurukshetra University, Kurukshetra, Haryana, by attachment dated 19.10.2023.

Several objections dated 09.02.2023, 15.02.2023, 25.03.2023 & 11.07.2023 were raised by this office asking him to provide the attested copies of LL.M. credentials and also, papers relating to the recognition of Kurukshetra University & approval of the course pursued by him & further, in reply thereto, he has furnished desired documents/clarification by attachment dated 10.02.2023, 23.03.2023, 02.06.2023 & 19.10.2023.

In this connection, it is submitted that Sri Bhupendra Pratap, joined U.P. Judicial Service on 06.01.2010 as Additional Civil Judge (Junior Division), Mathura. Besides, as evident from submitted attested copies of Mark-sheets (Two- years) and Degree of LL.M., Sri Bhupendra Pratap completed two years LL.M. course (from distance learning mode) in the year Dec 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.03.2023 for the session May 2022, thus the said qualification may be included in his service-records.

In this context, it Sri Bhupendra Pratap has furnished the copy of documents related to recognition of Kurukshetra University and approval of LL.M. course by University Grants Commission by attachment dated 19.10.2023 consisting the letter dated 18.10.2018 of Secretary of University Grant Commission under the heading of "Approval of Courses" & letter dated 13.08.20218 of the Director(DE), Kurukshetra University, Kurukshetra alongwith its enclosure dated 25.06.2018 under the heading of "Recognition letter DDE".

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sri Bhupendra Pratap, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 05.02.2023 of Sri Bhupendra Pratap, Additional District & Sessions Judge, Saharanpur may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Saharanpur for His Lordship's kind perusal and order to the effect that a copy of his application along with copy of Mark-sheets (two years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Bhupendra Pratap, Additional District & Sessions Judge,

Saharanpur, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
