May kindly see the online requisition dated 08.02.2023 of Sri Jeetendra Mishra, the then Special Judge (E.C.Act), Mirzapur & now posted as Additional District Judge(POCSO), Mainpuri requesting for inclusion of LL.M. qualification in his service records vide Case Id No. 27902023. In view of the above, Sri Jeetendra Mishra, has furnished his duly attested scanned copies of LL.M. Mark-sheets of two years and of the Degree Qualification, as supporting documents for the same.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets and of the Degree Qualification, Sri Jeetendra Mishra, aforesaid has completed his two-year LL.M. degree course in the year 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 31.03.2023, thus, the said qualification may be included in her service records, as prayed for.

Several objections dated 10.02.2023 & 11.07.2023 were raised by this office and in reply, desired documents & clarification/supporting documents have been provided by attachment dated 13.06.2023 & 26.07.2023.

In connection with the above, it is submitted that Sri Jeetendra Mishra, joined the U.P. Judicial Service on 26.06.2006, initially as Judicial Magistrate, Bareilly. Further, it is relevant to mention here that Sri Jeetendra Mishra, pursued her two-year LL.M. degree course from Kurukshetra University, Kurukshetra, Haryana in the year 2020-2022, after joining the judicial service with due approval of this court, the letter of permission so obtained has been furnished by attachment dated 26.07.2023.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Jeetendra Mishra, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 08.02.2023 of Sri Jeetendra Mishra, Additional District Judge (POCSO), Mainpuri to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Mainpuri for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Jeetendra Mishra, Additional District Judge (POCSO), Mainpuri may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
