May kindly see online request dated 10.02.2023 of Sri Prikshit, Nyayadhikari, Gram Nyayalaya, Siyana, Bulandshahar accompanied with resignation notice dated 10.02.2023 (**Annexure under heading Digitally Signed Application**) forwarded by the District Judge, Bulandshahar, addressed to The Hon'ble Governor, U.P. through proper channel, requesting therein to relieve him from U.P.Nyayik Sewa, while waiving prescribed notice period in accordance with The U.P.Temporary Government Servants(Termination of Service) Rules, 1975.

In this context it is submitted that vide aforesaid notice dated 10.02.2023, Sri Prikshit has informed that he was appointed in U.P.Judicial Services vide Hon'ble High Court Notification no. 4156/Admin(Services)/2019 dated 13.12.2019 and is presently serving as Nyayadhikari, Gram Nyayalaya, Siyana, Bulandshahar. Going further, he has informed that he appeared in Haryana Civil Services (Judicial Branch) Examination 2020-21 after obtaining permission from Hon'ble High Court, at every stage of exam.

Further, he has informed that vide Notification no. 25/01/2020-1SIII dated 27.01.2023 (**Annexure under heading Appointment Letter issued to applicant**) of Joint Secretary Services-III for Chief Secretary to Government, Haryana vide endorsement No. 46/Gaz.I/VI.M.46 dated 09.02.2023 (**Annexure under heading Posting Order of Hon'ble High Court of Punjab & Haryana with request to relieve at Serial No 4 of Page 12**) of Hon'ble High Court of Punjab & Haryana, he has been appointed as an officer in the Haryana Judicial Services and has been directed to join at the earliest.

Thus, he has tendered his resignation vide notice dated 10.02.2023 accompanied with the request to be relieved from duties, keeping in view the provisions of The U.P.Temporary Government Servants (Termination of Service) Rules, 1975, thereby enabling him to join Haryana Judicial Services, while waiving stipulated notice period as well as deciding over the issue of lien, in light of relevant rules.

In this context it is submitted that as Sri Prikshit recently entered into U.P.Judicial Services (i.e on 13.02.2020), the nature of his employment is still that of a temporary employee and is not entitled to hold any lien with U.P.Judicial Services. Further, he completed procedure of selection including interview for Haryana Judicial Services after obtaining permission of Hon'ble High Court, thus there seems no difficulty in relieving him from U.P.Judicial Services.

In this respect it is further submitted that relieving requests of temporary employees are carried out in accordance with **Rule-3 of The U.P.Temporary Government Servants(Termination of Service) Rules, 1975 which provides as quoted here under :**

3. Termination of service : (1)the services of a Government Servant in temporary service shall be liable to termination at any time by notice in writing given either by the Government servant to the appointing authority or by the appointing authority to the Government servant.

(2) the period of notice shall be one month

Provided further that it shall be open to the appointing authority to relieve a Government servant without any notice or accept notice for a shorter period, without requiring the Government servant to pay any penalty in lieu of notice.

In instant matter, since the appointing authority is the Government of U.P, thus request regarding acceptance of resignation/relieving from service/waiving prescribed notice period has to be sent to the Government of U.P. for necessary orders.

Further, as per reports obtained from concerned departments, there is no departmental/vigilance enquiry pending against Sri Prikshit, Nyayadhikari, Gram Nyayalaya, Siyana, Bulandshahar.

In the view of above submitted facts and information, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Pritinker Diwaker, Acting Chief Justice for His Lordship's kind perusal and order to the effect that request dated 10.02.2023, submitted via E-servicesJO portal, containing resignation notice of Sri Prikshit, Nyayadhikari, Gram Nyayalaya, Siyana, Bulandshahar as well as aforesaid information about nature of his employment, notice period, relieving date, lien detail etc. may be sent to the Special Secretary, Appointment Section-4, Government of U.P, Lucknow with necessary recommendation of Hon'ble Court, **for relieving Sri Prikshit, Nyayadhikari, Gram Nyayalaya, Siyana, Bulandshahar from U.P.Judicial Services, in accordance with Rule-3 of The U.P.Temporary Government Servants(Termination of Service) Rules, 1975, while waiving prescribed notice period ?**
