May kindly see the online requisition dated 13.02.2023 of Sushri Aayushi Pandey, posted as, Judicial Magistrate, Mainpuri, requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 28142023. In view of the above, Sushri Aayushi Pandey, has furnished her duly attested scanned copies of LL.M. Mark-sheets (previous & final years) and of the Degree Qualification, as supporting documents for the same.

Meanwhile, an objection dated 15.02.2023, was raised by the office of this court and further, in reply, Sushri Aayushi Pandey, aforesaid, has duly furnished the required documents by attachments dated 15.02.2023 for the purpose of inclusion of the said Degree.

In the connection with the above, it is submitted that Sushri Aayushi Pandey, joined the U.P. Judicial Service on 18.11.2019, initially as Additional Civil Judge(Junior Division), Mainpuri. Further, it is relevant to mention here that Sushri Aayushi Pandey, pursued her LL.M. course for the session 2019-2021, from Distance Learning Education from Kurukshetra University after duly taking permission from this Hon'ble court in the middle of the course, through online portal, after Joining the Judicial Service. The copy of the permission letter so obtained has been furnished by the attachment dated 13.02.2023.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (previous & final years) and copy of the Degree Qualification, Sushri Aayushi Pandey, completed her two-year LL.M. degree course in the year 2021 and was subsequently awarded Degree from Kurukshetra University, Haryana on 15.12.2022 thus, the said qualification may be included in her service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sushri Aayushi Pandey, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid requisition dated 13.02.2023 of Sushri Aayushi Pandey, Judicial Magistrate, Mainpuri to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Mainpuri, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (Two years) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sushri Aayushi Pandey, Judicial Magistrate, Mainpuri, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter, without entering into the fact that the Uninversity is recogniged by Uninversity Grants Commission or not and without reserving any future claim of the officer regarding her qualification, if the University is not recognised for LL.M Degree Qualification.
