May kindly see the online application of Smt. Anuradha, Addl. Civil Judge (Junior Div/), Allahabad regarding grant of permission to visit Singapore in Summer Vacation between 11th June 2023 to 30th June 2023 for 6 days 5 night tour(as per availability of tickets).

In her application, Sushri Anuradha has stated that she has valid Passport (No. W4765325) issued on 08/12/2022 which is valid till 07/12/2032 (copy of passport can be seen in attachment). The expenses of the proposed foreign trip would be borne by her and proposed expenses is Rs. 1,00,000/- (Estimated expenditure can be seen in attachment). She has also enclosed the copy of statement of her Savings Account No. 1001000100729764, having balance amount of Rs. 1,43,554/- (can be seen in attachment). She has also declared the following points:-

- 1. Her Journey is scheduled in summer vacation between 11th June 2023 to 30th June 2023
- 2. She is citizen of Republic of India by birth
- 3. She will not do any act in Singapore which harms the integrity and sovereignty of Republic of India.
- 4. Her foreign trip will not bring insult or shame to Republic of India and State of Uttar Pradesh
- 5. Her foreign trip will not affect Republic of India's friendly relation with any other country.
- 6. Her foreign trip will not threaten security of Republic of India.
- 7. There is no criminal case pending against her in any court in Republic of India.

8. That by her abroad visit, no dilemma is likely to create before the Govt of India or before Government of Uttar Pradesh

9. That such type of request for abroad visit was not refused to her earlier

10. That she have never visited any foreign country before her date of joining

She has, therefore, requested to place her application before the Hon'ble Court for grant of permission for the aforesaid visit.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, no vigilance/ departmental enquiry is pending against Smt. Anuradha. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during working days of the Hon'ble Court or during the period of suspension/ departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. In the instant case the officer wants to visit Singapore in Summer Vacation between 11th June 2023 to 30th June 2023 for 6 days 5 night tour(as per availability of tickets), thus her request appears to be considerable. Now its upto the discretion of Hon'ble The Acting Chief Justice and Hon'ble Administrative Judge, Allahabad either to grant her permission to visit Singapore in Summer Vacation between 11th June 2023 to 30th June 2023 for 6 days 5 night tour(as per availability of tickets) or to pass any other order. It is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or in the District of any deputation post, subject to approval by Hon'ble The Chief Justice or any member of the Administrative Committee authorised by Hon'ble The Chief Justice. Vide subsequent order dated 19.10.2020, Hon'ble the Chief Justice has been pleased to nominate Hon'ble Mr. Justice Pritinker Diwaker, to consider request of permission of the Judicial Officers to visit abroad in his place.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Allahabad for kind perusal and if His Lordship approves, Smt. Anuradha, Addl. Civil Judge (Junior Div/), Allahabad may be granted permission to visit Singapore in Summer Vacation between 11th June 2023 to 30th June 2023 for 6 days 5 night tour(as per availability of tickets), as requested, subject to approval by Hon'ble Mr. Justice Pritinker Diwaker, Hon'ble The Acting Chief Justice, as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 19.10.2020 of Hon'ble The Chief Justice, as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?
