May kindly see the online requisition dated 28.02.2023 of Sri Mohd. Sajid-I, the then Civil Judge(Senior Division), Budaun & presently posted as Chief Judicial Magistrate, Budaun requesting for inclusion of LL.M. qualification in his service records vide Case Id No. 28742023. In support of his application, Sri Mohd. Sajid-I has furnished attested copies of LL.M. credentials comprising of LL.M. Mark-sheets of both the years and copy of Degree for inclusion of his qualification in the service records. Along with his LL.M. credentials, he has also furnished the copy of online permission letter by attachment dated 08.10.2023 to pursue LL.M. through distance learning mode from Kurukshetra University, Kurukshetra.

In this connection, it is submitted that Sri Mohd. Sajid-I, joined the U.P. Judicial Service on 13.01.2017 as Additional Civil Judge (Junior Division), Moradabad. Besides, as evident from submitted attested copies of Mark-sheets (Two- years) and Degree of LL.M., Sri Mohd. Sajid-I completed two years LL.M. course (from distance learning mode) in the year Dec 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.03.2023 for the session May 2022, thus said qualification may be included in his service-records.

In this context, it Sri Mohd. Sajid has furnished the copy of documents related to recognition of Kurukshetra University and approval of LL.M. course by University Grants Commission by attachment dated 08.10.2023 consisting the letter dated 18.10.2018 of Secretary of University Grant Commission & letter dated 13.08.20218 of the Director(DE), Kurukshetra University, Kurukshetra .

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sri Mohd. Sajid-I, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 28.02.2023 of Sri Mohd. Sajid, Chief Judicial Magistrate, Budaun may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Budaun for His Lordship's kind perusal and order to the effect that a copy of her application along with copy of Mark-sheets (two years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Mohd. Sajid-I, Chief Judicial Magistrate, Budaun, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
