

### **I/c Joint Registrar (Judicial) (Budget)**

May kindly see the online application of Sri Rahul Anand-III, Nyayadhikari, Gram Nyayalaya Campierganj-Gorakhpur regarding grant of permission to visit United Kingdom & Europe (Denmark, Norway & Finland) alongwith his wife Smt. Sushma Rani from 10.06.2023 to 20.06.2023 i.e. during summer vacation in June 2023.

In his application, Sri Rahul Anand-III has stated that he wishes to visit United Kingdom & Europe (Denmark, Norway & Finland) along with his wife Smt. Sushma Rani (Radiologist in Fatima Hospital Gorakhpur), from 10.06.2023 to 20.06.2023 i.e. during summer vacation in June 2023. He has also submitted that he wishes to go to the above-mentioned countries for tour purpose only. The officer has stated that the tour expenses would be approx. of Rs. 2,20,000/- per person which would be borne by the officer and his wife separately from their salary accounts. He has also submitted copies of, their passport and statement of his own and his wife's bank account, showing balance of Rs. 2,34,988/- & Rs. 6,80,996/- respectively, which can be seen as attachments. He has further added that in order to apply for Visa /booking and to initiate other formalities, he needs permission from the Hon'ble Court to visit United Kingdom & Europe (Denmark, Norway & Finland) and declares the following:

1- That by his abroad visit, no dilemma is likely to create before the Government of India or the Government of U.P.

2- That such type of request for abroad visit has not been refused earlier.

3- That before joining this service, he had pursued his LL.M from Queen Mary University of London, UK for which the applicant stayed in the London, UK from September 2015- January 2017. During his stay in UK, the applicant also visited Europe for tour and study purpose.

4- That on 19.05.2022, the applicant had applied for issue of no objection Identity Certificate for renewal/obtaining passport which was approved by the Hon'ble High Court and Identity Certificate was issued on 14.02.2023 with the direction that the applicant should take prior permission of the Hon'ble Court before proceeding abroad.

He has, therefore, most humbly requested to place his request before the Hon'ble Court, to grant him permission to visit United Kingdom & Europe (Denmark, Norway & Finland) alongwith his wife.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, provided by concerned sections no vigilance/ departmental enquiry is pending against Sri Rahul Anand-III. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, **Abroad tour by any officer shall not be availed of during working days of the Hon'ble Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. Now, in the instant case the officer is going to visit United Kingdom & Europe (Denmark, Norway & Finland) alongwith his wife, Smt. Sushma Rani (Radiologist in Fatima Hospital Gorakhpur) during summer vacation for tourism purpose from 10.06.2023 to 20.06.2023, thus, this trip appears to be a pleasure trip which completely falls during summer vacation and thus, his request appears to be considerable. However, it is on the discretion of the Hon'ble High Court either to grant him permission or to pass any other order which deems to be proper. In this connection it is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble The Chief Justice or any member of the Administrative Committee authorised by Hon'ble The Chief Justice. Recently, vide order dated 23.04.2023 regarding reconstitution of different Committees, Hon'ble The Chief Justice has been pleased to form a single Hon'ble Judge Committee i.e. Hon'ble Senior Judge (J-1) to deal with the matter of grant of permission to Judicial Officers to visit abroad**

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Rahul Chaturvedi, Administrative Judge, Gorakhpur for kind perusal and if His Lordship approves, Sri Rahul Anand-III, Nyayadhikari, Gram Nyayalaya Campierganj-Gorakhpur may be granted permission to visit United Kingdom & Europe (Denmark, Norway & Finland) along with his wife Sushma Rani (Radiologist in Fatima Hospital Gorakhpur) from 10.06.2023 to 20.06.2023 i.e. during summer vacation, for tourism purpose, as requested, subject to approval by Hon'ble The Senior Judge (J-1), as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 23.04.2023 of Hon'ble the Chief Justice, as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with him, may be handed over by him before proceeding abroad?

Or

To pass any other order, which His/ Her Lordship deems fit and proper.
