May kindly see the online application of Sri Mayuresh Srivastav, Judicial Magistrate, Agra who joined service on 15.06.2018, drawing gross salary of Rs. 97,484/- & take home salary of Rs. 83,642/- regarding information about purchase of a new Maruti Suzuki Alto car, allotted reg. no. UP 54AU 4461 (Copy of RC can be seen as attachment namely- Registration Certificate), intimated through application dated 15.03.2023.

Through his application, Sri Mayuresh Srivastav, has submitted information about purchase of a new car on 13.12.2022 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Smartwheels Pvt. Ltd., Mohaddiur, Gorakhpur for Rs. 6,00,001/- in total (Copy of Sale invoice can be seen as attachment namely- Sale invoice of purchased car), source of money of which is that Rs. 4,00,000/- has been taken as loan from State Bank of India, Mohaddipur, Gorakhpur repayable in 60 monthly EMIs of Rs. 8,255/- (copy of 'loan paper' can be seen as attachment namely- loan detail), Rs. 70,001/- is stated to have been paid through his saving account (copy of statement of A/c can be seen as attachment namely- Salary Statement), Rs. 1,30,000/- is stated to have been paid in cash (copy of receipt can be seen as attachment namely- Receipts of transaction made for purchase of car). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

It is noteworthy to mention here that the officer sold his old car bearing reg no. UP 50Y 9860 (Copy of old RC can be seen as attachment) to Mr. Ramagya Yadav S/o Late Chauthi Yadav R/o Khanpur Bujurg, Post Ghosi, P.S. and Tehsil Ghosi Mau, Uttar Pradesh on 12-12-2022 for Rs. 1,30,000/- (Copy of Affidavit can be seen as attachment) and information has been sent to Hon'ble Court vide application no. S00027162023.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Agra for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
