May kindly see the online requisition dated 20.03.2023 of Sushri Rewa, the then Additional Civil Judge(Junior Division) Bhadohi at Gyanpur & now posted as Additional Civil Judge(Junior Division), Kanpur Nagar, requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 29292023. In view of the above, Sushri Rewa, has furnished her duly attested scanned copies of LL.M. Mark-sheets (all semesters as well as Consolidated) and of the Degree Qualification, as supporting documents for the same.

Several objections were raised by this office on 22-03-2023 & 18.05.2023 and further, in reply she has submitted the required copies of document & clarification by attachment dated 22.03.2023 & 22.05.2023 respectively.

In the connection with the above, it is submitted that Sushri Rewa, joined the U.P. Judicial Service on 15.11.2019, initially as Additional Civil Judge(Junior Division), Bhadohi at Gyanpur. Further, it is relevant to mention here that Sushri Rewa, pursued her LL.M. course for the session 2017-2019, from University of Allahabad, Allahabad prior to Joining the Judicial Service, as per the records.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (all semesters) and copy of the Degree Qualification, Sushri Rewa, completed her two-year LL.M. degree course in the year 2019 and was subsequently awarded Degree from University of Allahabad, Allahabad on 26.02.2021, thus the said qualification may be included in her service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sushri Rewa, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid requisition dated 20.03.2023 of Sushri Rewa, Additional Civil Judge (Junior Division), Kanpur Nagar to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Siddharth , Administrative Judge, Kanpur Nagar, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (four semesters as well as consolidated) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sushri Rewa, Additional Civil Judge(Junior Division), Kanpur Nagar, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter, without entering into the fact that the University is recognised by University Grants Commission or not and without reserving any future claim of the officer regarding her qualification, if the University is not recognised for LL.M Degree Qualification.
