May kindly see the online requisition dated 21.03.2023 of Sri Varun Kaushik posted as Nyayadhikari, Gram Nyayalaya, Baraut, Baghpat, requesting for inclusion of his LL.M. qualification in his service records vide Case Id No. 39352023. In view of the above, Sri Varun Kaushik, has furnished his duly attested scanned copies of LL.M. Mark-sheets (previous & final years) and of the Degree Qualification, as supporting documents for the same.

In connection with the above, it is submitted that Sri Varun Kaushik joined the U.P. Judicial Service on 18.11.2019, initially as Civil Judge (Junior Division), Baghpat. Further, it is relevant to mention here that Sri Varun Kaushik, pursued his LL.M. two-year degree course from Kurukshetra University, Kurukshetra, Haryana, in the academic year 2019-2021, after duly taking permission from this Hon'ble court in the middle of the course, through online portal, after Joining the Judicial Service, as per the records.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (previous & final years) and copy of the Degree Qualification Sri Varun Kaushik, completed his two-year LL.M. degree course in the year 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 31.08.2022, thus, the said qualification may be included in his service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Varun Kaushik, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 21.03.2023 of Sri Varun Kaushik, Nyayadhikari, Gram Nyayalaya, Baraut, Baghpat to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (previous & final years) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Varun Kaushik, Nyayadhikari, Gram Nyayalaya, Baraut, Baghpat may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter, without entering into the fact that the University is recognised by Uninversity Grants Commission or not and without reserving any future claim of the officer regarding his qualification, if the University is not recognised for LL.M Degree Qualification.
