May kindly see the online application/request through case id no. 29432023 dated 23.03.2023 of Sri Kapil Yadav, the then Civil Judge (Junior Division), Firozabad, presently posted as Additional Civil Judge (Junior Division), Pratapgarh whereby he has requested for inclusion of his LL.M. qualification in his service records.

Sri Kapil Yadav, in his application, has submitted that, he has pursued LL.M. Course through Kurukshetra University, Haryana prior to joining the Judicial Service and he successfully pursued LL.M. distance learning course/program in May, 2019 from Kurukshetra University, Haryana and would like to add this educational achievement in his Service Record. He has, therefore, requested for addition of LL.M. Degree in Service Record.

In support of the same, Sri Kapil Yadav, has furnished copies of recognition-related papers of the University (attachment sl. nos. 2-3), and his LL.M. credentials comprising attested copies of Mark-sheets of both the years (attachment s.no. 1) and degree (attachment sl. no. 4).

An objection dated 10.07.2023 was raised by this office to furnish the documents related to recognition of the Kurukshetra University by UGC & approval of LL.M. course pursued by him through Online & Distance Learning Mode for relevant years. In reply, he has furnished the copy of University documents by attachment dated 01.09.2023 at attachment sl. no. 2 & 3. Further another objection dated 13.10.2023 was raised to furnish the clearly scanned and attested copy of LL.M Degree Qualification & to clarify the reason that the 1st year marksheet was issued on 20.04.2022 whereas the 2nd year marksheet has been issued on 01.06.2020 i.e. before 1st year, & in reply thereto, he has furnished the desired document by attachment dated 05.01.2024 at attachment sl. no. 4 and clarification mentioning that the 1st year marksheet was reissued on 20.04.2022 by the concerned university since it was misplaced.

In this context, it is submitted that Sri Kapil Yadav, aforesaid joined the U.P. Judicial Service on 16.12.2019 Civil Judge (Junior Division), Firozabad. Besides, as evident from submitted attested copies of Mark-sheets of both the years and the Degree qualification of LL.M., he has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 15.11.2022 for the examination year May 2019.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Kapil Yadav, aforesaid with the order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/request dated 23.03.2023 of Sri Kapil Yadav, the then Civil Judge (Junior Division), Firozabad, presently posted as Additional Civil Judge (Junior Division), Pratapgarh may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice J. J. Munir, Administrative Judge, Pratapgarh for His Lordship's kind perusal and if His Lordship approves, a copy of online application/request dated 23.03.2023 of Sri Kapil Yadav, the then Civil Judge (Junior Division), Firozabad, presently posted as Additional Civil Judge (Junior Division), Pratapgarh, along with copies of Degree of LL.M. and Mark-sheets of both the years of LL.M. examination, as well as attested copy of his form of U.P. Nyayik Sewa, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of LL.M. degree in his service records?
