May kindly see the online application of Sushri Meher Jahan, Judicial Magistrate, Auraiya regarding grant of permission to visit Oxford, U.K. to meet her husband from 21.06.2023 to 16.07.2023.

In her application, Sushri Meher Jahan has stated that she wants to visit Oxford, U.K. to meet her husband (pursuing PhD from University of Oxford) from 21.06.2023 to 16.07.2023 (10 days summer vacation & 16 days suffixing Earned Leave). Since she would be visiting her husband, would be undertaking a long journey and also would be incurring a lot expenditure in doing so. So, as a special case she requested to allow her to extend her period of visit by taking Earned Leave (EL) from 1st July to 16th July 2023. She has also stated that the expenditure of this tour is approx. Rs. 75,000/- to Rs. 80,000/- i.e flight expenses of proposed trip would be borne by her and other expenses including lodging & fooding would be borne by her husband. She has also enclosed the copy of her passport and copy of passbook of her bank account (showing balance amount of Rs. 1,91,501/-), which can be seen as attachments. She has also submitted her declaration which are as follows:-

- 1- That by her abroad visit, no dilemma is likely to create before the Government of India or the Government of U.P.
- 2- That such type of request for abroad visit has not been refused earlier.
- 3- That she had visited U.K. to meet her husband in June-July 2022.

She has, therefore, requested to grant her permission to visit U.K to meet her husband.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, provided by concerned sections no vigilance/ departmental enquiry is pending against Sushri Meher Jahan. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IVf-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during Hon'ble Court working days o f the or during the period suspension/departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. Now, in the instant case the officer is going to visit Oxford, U.K. to meet her husband from 12.06.2023 to 21.06.2023 (10 days summer vacation & 16 days suffixing Earned Leave). It is on the discretion of the Hon'ble High Court either to grant her permission or to pass any other order which deems to be proper. In this connection it is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or in the District of any deputation post, subject to approval by Hon'ble The Chief Justice or any member of the Administrative Committee authorised by Hon'ble The Chief Justice. Recently, vide order dated 23.04.2023 regarding reconstitution of different Committees, Hon'ble The Chief Justice has been pleased to form a single Hon'ble Judge Committee i.e. Hon'ble Senior Judge (J-1) to deal with the matter of grant of permission to Judicial Officers to visit abroad

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Ram Manohar Narayan Mishra, Administrative Judge, Auraiya for kind perusal and if His Lordship approves, Sushri Meher Jahan, Judicial Magistrate, Auraiya may be granted permission to visit Oxford, U.K. to meet her husband (pursuing PhD from University of Oxford) from 21.06.2023 to 16.07.2023 (10 days summer vacation & 16 days suffixing Earned Leave), as requested, subject to approval by Hon'ble Mrs. Justice Sunita Agarwal, The Senior Judge (J-1), as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 23.04.2023 of Hon'ble The Chief Justice, as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with her,

may be handed over by her before proceeding abroad?

To pass any other order, which His/ Her Lordship deems fit and proper.
