May kindly see the online requisition dated 28.03.2023 of Smt. Shubhi Agrawal, the then Civil Judge(Junior Division), Pilibhit & now posted as Additional Civil Judge(Junior Division), Varanasi requesting for inclusion of LL.M. qualification in her service records vide Case Id No. 29552023. In view of the above, Smt. Shubhi Agrawal, has furnished her duly attested scanned copies of LL.M. Mark-sheets of two years and of the Degree Qualification as well as documents related to the University, as supporting documents for the same.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets and of the Degree Qualification, Smt. Shubhi Agrawal, aforesaid has completed her two-year LL.M. degree course in the year 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 31.08.2022, thus the said qualification may be included in her service records, as prayed for.

Several objections dated 30.03.2023 & 10.07.2023 were raised by this office and in reply, desired documents & clarification/supporting documents have been provided by attachment dated 30.03.2023 & 23.07.2023.

In connection with the above, it is submitted that Smt. Shubhi Agrawal, joined the U.P. Judicial Service on 15.11.2019, initially as Additional Civil Judge(Junior Division), Bulandshahar. Further, it is relevant to mention here that Smt. Shubhi Agrawal, pursued her two-year LL.M. degree course from Kurukshetra University, Kurukshetra, Haryana in the year 2019-2021, after joining the judicial service in the middle of the course, with due permission of this court, the letter of permission so obtained has been furnished by attachment dated 23.07.2023.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Smt. Shubhi Agrawal, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 28.03.2023 of Smt. Shubhi Agrawal, Additional Civil Judge(Junior Division), Varanasi to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Varanasi for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of mt. Shubhi Agrawal, Additional Civil Judge(Junior Division), Varanasi may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
