May kindly see the online application of Sri Ramayan Sharma, Principal Judge, Family Court, Ayodhya regarding grant of permission to publish a draft book titled "Criminal Trial-Sui generis".

In his application, Sri Ramayan Sharma has stated that he has written a book titled "Criminal Trial-Sui generis" which he wishes to get published. His draft book is strict per conditions/provisions laid down in the Govt. O.M. no. 3143/II-B, Dated 11.10.1968 as per Rules 5 & 15 of U.P. Govt. Servants Conduct Rules, 1956. He has therefore, requested to kindly place his application before the Hon'ble Court for its kind consideration and permission to get his draft published as a book on the conditions mentioned below:-

(1) He hereby declares that the book does not bear the imprimatur of Government

(2) He hereby declares that the author's name appears on the first page of the book without his official designation.

(3) He hereby declares that the author will give a statement under his name on the first page of the book or at any suitable place that the views and comments in the book are entirely the responsibility of the author and the Government are in no way concerned with the publication of the book.

(4) He hereby declares that the the author should also ensure that the book does not contain any statement of fact or opinion which has any adverse criticism of any current or recent policy or action of the State or Central Government or Government of any other state or local authority.

(5) He hereby declares that the book is written solely with the aid of the knowledge acquired in the course of service, but it is not a mere compilation of Government rules, regulations or procedures, but reveals the author's literary work and scholarly study of the subject.

(6) He hereby declares that the work neither has nor is likely to have any connection with the author's official positions; no part of the income recurring or unrecurring derived by him from the sale proceeds or royalties of the book need be credited to the general revenues.

It is further submitted that as the officer has already submitted the declarations that he will abide by the conditions of Govt. O.M. no. O-3134/II-B-1968 dated 11.12.1968 of rule 15 of U.P. Govt. Servant's Conduct Rules 1956, his case may be considered, but, acceptance of the request of the officer to write & get published the book is on discretion of the Court. Moreover it is pertinent to mention here that the name of the publisher/co-publisher has not yet been decided by him & the details of royalty has also not been disclosed yet.

Under the facts and circumstances, if approved, the file be laid before Hon'ble Mrs. Justice Sunita Agarwal, Senior Judge (J-1) as per order dated 23.04.2023 of Hon'ble The Chief Justice for the purpose, for Her Lordship's kind perusal and if Her Lordship approves, Sri Ramayan Sharma, Principal Judge, Family Court, Ayodhya be granted permission to publish a draft book titled "Criminal Trial-Sui generis", as requested, subject to the conditions of Govt. O.M. No. O-3143/ II-B-1968, dated 11.12.1968?
