May kindly see the online requisition dated 12.04.2023 of Sri Shiv Shakti Harsh Vardhan, Civil Judge(Junior Division), Sitapur requesting for inclusion of his LL.M. qualification in his service records vide Case Id No.30042023. In view of the above, Sri Shiv Shakti Harsh Vardhan, has furnished his duly attested scanned copies of LL.M. Mark-sheets (all semesters as well as Consolidated) and of the Degree Qualification, as supporting documents for the same.

In the connection with the above, it is submitted that Sri Shiv Shakti Harsh Vardhan, joined the U.P. Judicial Service on 16.12.2019, initially as Civil Judge(Junior Division), Azamgarh. Further, it is relevant to mention here that Sri Shiv Shakti Harsh Vardhan, pursued his LL.M. course for the session 2017-2019, from University of Allahabad, Allahabad before joining the U.P. Judicial Service.

An objection dated 16.05.2023 was raised by this office with regard to clarification of the two dates mentioned in the degree certificate & in reply, he has submitted his clarification by submission dated 26.07.2023 mentioning that one is date of issuance of degree certificate and the second is date of request by the candidate for issuance of the degree.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (all semesters) and copy of the Degree Qualification, Sri Shiv Shakti Harsh Vardhan, completed his two-year LL.M. degree course in the year 2019 and was subsequently awarded Degree from University of Allahabad, Allahabad on 26.02.2021, thus the said qualification may be included in his service records, as is prayed for.

Further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Shiv Shakti Harsh Vardhan, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid requisition dated 12.04.2023 of Sri Shiv Shakti Harsh Vardhan, Civil Judge(Junior Division), Sitapur to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Sitapur for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (four semesters as well as consolidated) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Shiv Shakti Harsh Vardhan, Civil Judge(Junior Division), Sitapur may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
