May kindly see the online application/ request vide case id 30172023 dated 14.04.2023 of Smt. Samreen Fatima Nomani, the then Additional Civil Judge (Junior Division), Azamgarh, presently posted as Additional Civil Judge(Junior Division), Ghaziabad whereby she has requested for inclusion of her LL.M. qualification in the service records.

In support of the same, Smt. Samreen Fatima Nomani has furnished copy of online permission letter of this Court regarding grant of earlier permission (attachment sl. no. 6) by attachment dated 18.09.2023, copies of recognition-related papers of the University (from attachment sl. no. 7 to 9) by attachment dated 11.10.2023, and his LL.M. credentials comprising attested copies of Mark-sheets of both the years(at attachment sl. no. 10-11) and degree (at attachment sl. no. 12) by attachment dated 08.01.2024 hereon this portal.

Several objections dated 18.04.2023, 22.09.2023 & 23.11.2023 were raised by this office with regard to requisite documents and necessary clarification & in reply, thereto, she has furnished the desired documents by response dated 18.09.2023, 11.10.2023 & 08.01.2024 respectively.

In this context, it is submitted that Smt. Samreen Fatima Nomani, aforesaid joined the U.P. Judicial Service on 18.11.2019 as Additional Civil Judge(Junior Division), Azamgarh. Besides, as evident from submitted attested copies of Mark-sheets of both the years and the Degree qualification of LL.M., she has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.03.2023 for the examination year May 2022 for LL.M. II (final year) marksheet issued on 10.12.2022 as well as for 1st year issued on 09.02.2022. She has pursued the aforesaid LL.M. Course with the prior permission of this Court and copy of the same has been furnished (attachment sl. no. 6) by attachment dated 18.09.2023.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Smt. Samreen Fatima Nomani, aforesaid with the formal order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/request dated 14.04.2023 of Smt. Samreen Fatima Nomani, the then Additional Civil Judge (Junior Division), Azamgarh, presently posted as Additional Civil Judge(Junior Division), Ghaziabad may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad for His Lordship's kind perusal and if His Lordship approves, a copy of online application/request dated 14.04.2023 of Smt. Samreen Fatima Nomani, the then Additional Civil Judge (Junior Division), Azamgarh, presently posted as Additional Civil Judge(Junior Division), Ghaziabad along with copies of, Degree of LL.M. and Mark-sheets of both the years of LL.M. examination, as well as attested copy of his form of U.P. Judicial Service, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of LL.M. degree in her service records?
