May kindly see the online application/ request vide case id S00030222023 dated 16.04.2023 of Smt. Ankita Singh-III, Additional Civil Judge (Junior Division), Fatehpur, whereby she has requested for inclusion of her LL.M. qualification in the service records.

In support of the same, on 16.04.2023, Smt. Ankita Singh-III, aforesaid furnished, copies of her mark-sheet of LL.M. Part-I & II alongwith the approval of this Hon'ble Court regarding grant of permission to pursue LL.M. course, on this portal as attachments dated 16.04.2023. Therefore, vide this office objection dated 09.05.2023, she was asked to submit attested copy (not self-attested/unattested) of Mark-sheets of all the semesters/years (i.e. 1st year also) and the Degree qualification.

Going further, vide her response & attachment dated 22.02.2024, Smt. Ankita Singh-III submitted the said documents with a request to take further necessary action. However, there was found an anomaly in the issuance dates of her marksheets of LL.M. Part-I & II. Therefore, she was asked to clarify the reason as to why date of result of LL.M. Part-II is 26.04.2022 for exam year 2021 and dated of result of Part-I is 10.12.2022, while also clarifying the fact as to whether Kurushetra University, Haryana is recognized by University Grant Commission and the LL.M. Course pursued by him/her through Open & Distance Learning is/was approved by UGC for the relevant years with supporting papers.

In response the above objection, Smt. Ankita Singh-III, vide her submission dated 27.04.2024, has attached the required copies of relevant documents under headings as 'Annexure-1 to Annexure-5' and vide Annexure-1, she has submitted the relevant documents regarding the clarification about the recognition of Kurukshetra University by University Grant Commission as well as approval of her distance learning course by UGC for the respective years. Moreover, with respect to the anomaly in date of result of LL.M. Part-I & II, she has submitted that she has joined the LLM Course through Distance Learning in the year 2019 (before joining) after which she appeared for the LLM Part-1 exam in the year 2020 in which she got backlog in paper L002 (marksheets attached as annexure 2) and then she appeared for LLM Part-2 exam in the year 2021 but her dissertation Paper LN06 was not received by the university therefore they have marked "AB" in my paper LN06(attached as annexure 3). Meanwhile when her dissertation was received by the university, they have issued her the new marksheet dated 26.04.2022(attached as annexure 4). Further she added that she appeared for her backlog exam in Paper L002 for LLM Part-1 in August 2022 and therefore she got her marksheet for LLM Part-1 on 10.12.2022(attached as annexure 5).

In this context, it is submitted that Smt. Ankita Singh-III, aforesaid joined the U.P. Judicial Service on 14.11.2019 as Additional Civil Judge(Junior Division), Azamgarh. Besides, as evident from submitted attested copies of Mark-sheets of both the years and the Degree qualification of LL.M., she has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 28.12.2023 for the examination year May 2021 for LL.M. II (final year) marksheet dated 26.04.2022, issued on 21.05.2022 as well as of 1st year dated 10.12.2022, issued on 22.01.2023. She has pursued the aforesaid LL.M. Course with the prior permission of this Court and copy of the same has been furnished by attachment dated 16.04.2023 under heading 'Approval to pursue course'.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Smt. Ankita Singh-III, aforesaid with the formal order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/request dated 16.04.2023 of Smt. Ankita Singh-III, Additional Civil Judge (Junior Division), Fatehpur may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Fatehpur for His Lordship's kind perusal and if His Lordship approves, a copy of online application/request dated 16.04.2023 of Additional Civil Judge (Junior Division), Fatehpur along with copies of Degree of LL.M. and Mark-sheets of both the years of LL.M. examination, as well as attested copy of her form of U.P. Judicial Service, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of LL.M. degree in her service records?
