May kindly see the online office note dated 26.08.2023, upon which Hon'ble the Administrative Judge, Lalitpur vide His Lordship's order dated 27.10.2023 has been pleased to grant permission to Sri Mahesh Nautiyal, Principal Judge, Family Court, Lalitpur to visit Kathmandu (Nepal) for darshan of Lord Pashupath Nath temple there alongwith his family from 27.11.2023 to 02.12.2023, as requested. In this connection it is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission, the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice. Earlier, vide order dated 23.04.2023 regarding reconstitution of different Committees- Last modified on 29.08.2023, Hon'ble The Chief Justice has been pleased to form a single Hon'ble Judge Committee i.e. Hon'ble Senior Judge (J-1) to deal with the matter of grant of permission to Judicial Officers to visit abroad. As such the permission granted in this case vide order dated 27.10.2023 of Hon'ble the Administrative Judge, Lalitpur was submitted before Hon'ble Mr. Justice Surya Prakash Kesarwani, the then Hon'ble Senior Judge (J-1) for His Lordship's kind approval, however, the matter has been returned back without order after His Lordship's transfer.

Under the facts and circumstances mentioned above, if approved, the matter may now kindly be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Senior Judge (J-1), as per order dated 23.04.2023 of Hon'ble The Chief Justice regarding reconstitution of different Committees- Last modified on 29.08.2023, for His Lordship kind perusal and approval of His Lordship for grant of permission to Sri Mahesh Nautiyal, Principal Judge, Family Court, Lalitpur to visit Kathmandu (Nepal) for darshan of Lord Pashupath Nath temple there alongwith his family from 27.11.2023 to 02.12.2023, as requested and as already permitted/approved by Hon'ble the Administrative Judge, Lalitpur Judgeship, subject to the conditions that proper charge of Government records or cash, if any, or any government property with her, may be handed over by him before proceeding abroad?
