May kindly see the online application of Sri Arvind Malik, Principal Judge, Family Court, Moradabad for grant of permission to sell plot measuring 250 sq. yards situated at Chandpur, Bulandshahar which was purchased in the name of his spouse.

In his application, Sri Arvind Malik has stated that he has purchased a plot measuring 250 sq. yards situated at Chandpur, Bulandshahar prior to joining of this service and he has regularly disclosed in his property statement. The said plot had been purchased in the name of his wife Smt. Lata Malik Alias Dolly on 11.12.2007 (Copy of 'Sale Deed' can be seen as attachment). Now, he intends to sell off the said property for construction or purchase of a self dwelling house to Sri Ram Gopal Sharma S/o Sri Jai Prakash R/o H. No. 23, Radhika Enclave Kazampur Deoli, P.S. Kotwali dehat, Bulandshahar for Rs. 62,50,000/-. The proposed purchaser is neither related to him in any manner nor any of his case is decided or pending in his Court. He has, therefore, requested that he may be granted permission to sell the property as mentioned above.

In this connection, it is submitted that the property in question has been purchased by the officer prior to joining the judicial service. It is further submitted that as per Rule- 24 (1) of U.P. Government Servant's conduct Rule-1956:

"No Government servant shall, except with the previous knowledge of the appropriate authority acquire or dispose of any immovable property by lease, mortgage, purchase, sale, gift or otherwise, either in his own name or in the name of any member of his family;

Provided that any such transaction conducted otherwise than through a regular & reputed dealer shall require the previous sanction of the appropriate authority."

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge Moradabad, for His Lordship's kind perusal and if His Lordship approves, permission be accorded to Sri Arvind Malik, Principal Judge, Family Court, Moradabad to sell his immovable property i.e. plot measuring 250 sq. yards situated at Chandpur, Bulandshahar to Sri Ram Gopal Sharma S/o Sri Jai Prakash R/o H. No. 23, Radhika Enclave Kazampur Deoli, P.S. Kotwali dehat, Bulandshahar for Rs. 62,50,000/-, as requested, subject to the conditions that he should submit the relevant papers of the transaction after its completion?
