May kindly see the online application of Sri Arnav Raj Chakravarti, Civil Judge (Jr. Div.), Jalaun at Orai who joined service on 29.09.2018, drawing gross salary of Rs. 81,618/- & take home salary of Rs. 65,512/- regarding information about purchase of a new Mahindra XUV 300 W car, allotted reg. no. UP78FS0512, intimated through application dated 13.02.2020.

Through his application, Sri Arnav Raj Chakravarti has submitted information about purchase of a new car on 25.03.2019 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from V.C. Motors Pvt. Ltd., Rooma, plot no. 608-609, G.T. Road, Kanpur, for Rs. 11,72,677 including registration and other charges. The source of money of which is that Rs. 10,00,000/- (Rs. 5,00,000/- Rs. 3,20,000/- Rs. 1,80,000/-) is stated to have been paid out of his own S.B. A/c no. 2811361769, Kotak Mahindra, Kanpur through RTGS (copy of statement of A/c can be seen as attachment), Rs. 1,00,000/- (Rs. 80,000/- Rs. 20,000/-) is stated to have been taken from his mother Smt. Bandana Chakravarti, who was posted as Primary teacher in Central School, Chakeri, Kanpur Nagar) as interest free loan out of her S.B. A/c no. 10294195703 SBI, Kanpur Nagar (copy of statement of A/c as well as consent letter of his mother can be seen as attachment) & rest Rs. 72,677/- (Rs. 20,000/- Rs. 52,677/-) is stated to have been paid out of his own S.B. A/c no. 37958297920 SBI, Kanpur Nagar (Copy of statement of A/c can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Nominated Judge for disposal of the matters of Judicial Officers, of information/permission of sale/purchase of movable/immovable property or gift etc., for the District Jalaun for His Lordship's kind perusal, information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
